The camaraderie and enthusiasm was high. We surely missed many of our brothers and had hoped for a better showing. Give us your thoughts on holding our encampment before school is out.

#### MESSAGE FROM JVC CHRIS WORKMAN

I am writing in regards to some new business I brought before the Department at the Annual Encampment. I have recently accepted a position leading the Social Studies program at a local elementary school, while teaching 5th grade US History. This coming school year will be my first year in the position. Currently this school has the lowest Social Studies test scores of any school in our district. This reflects an overall decline in the emphasis placed on history education not only in this school, but also in our district and throughout the Commonwealth.

My primary goals in this position are to not only make this program the top Social Studies Program in our district, but to also create an environment where students, faculty staff and administration, parents and the community are excited about history education. I want to spark a passion that I know through various discussion throughout the previous year is there waiting just below the surface.

The school's administration is very supportive and excited about the changes that I am putting in the place for the coming school year. One change which I have proposed and which has been accepted by that administration is the addition of a Junior Historical Society. This will be an after school program which will meet twice a month and enable the students here to further explore US and Kentucky history as well as participate in local history service projects. This will also allow our school to participate in the annual Junior Historical Society conference held at the Kentucky History Center, where they can test their knowledge against other schools throughout the state in the annual History Bowl.

Another addition to the coming school year will be the addition of an annual history fair. Here students will research a selected topic from US history, create a display on the subject and then make a short presentation to those who visit the display (including judges).

A living history museum is also planned, where students will se3lect figures from US history and while dressed as these characters will present a living biography of the individual to those who stop at their station. These two activities combined with the Junior Historical Society will lead to the school's participation in the National History Day Competition.

The support from the school administration, faculty and staff, and the community has been tremendous. Word has already begun to spread throughout the student body and excitement is building. I'm confident that once this ball begins to roll that next year these programs and events will begin to take on lives of their own, and will be able to stand on their own two feet. It's getting the ball started that we are facing at the moment.

The primary purpose of the Sons of Union Veterans of the Civil War is to preserve and perpetuate the memory of our ancestors, their service and their sacrifices. While monument and headstone dedications are very much a part of our organization and are very important in remembering our ancestors, we would be doing those same ancestors an extreme disservice by failing to educate future generations of why they served, what they did, and who they are.

#### MESSAGE FROM JVC CHRIS WORKMAN

It is for this purpose that I asked the Department of Kentucky for a one-time contribution of four hundred dollars to help these programs get started and to help bring back an emphasis on history education that has been slowly slipping away. This money will directly allow students to participate in history-related activities and directly support their education through the support of the SU-VCW. Each and every one of these students represents the future of our Order, and the future of the memories of our ancestors.

#### REPORT FROM MEMORIALS OFFICER

#### ROBERT JONES

**Regarding events which** pertained to markers, memorials and monuments for the past year, I am pleased to report that the department has been busy. This has included the dedication of the interpretive marker for the Battle of Tebbs Bend, maintaining the Granville Allen Monument, the rededication of the Cave Hill Rostrum and campaign for its restoration, and the dedication of the Kentucky Highway Marker for the Harrods Creek Kentucky Soldiers Home.

Sept. 18, 2016. Dedication of the Battle of Tebbs Bend Interpretive Marker, Romine, Ky., Battle on July 4, 1863. Members of two Kentucky camps present.

Sept. 19, 2016. Rededication of the Rostrum at Cave Hill National Cemetery, Louisville, Ky. Originally dedicated in 1898 for use of the G.A.R. Dozens of department officers and members attended, along with members of the NSDU 1861-1865 and representatives from the mayor's office and the governor's office, as well as female members from Louisville Male High School Choir, who sang selections of songs sung during the original dedication in 1898. Local media coverage.

Nov. 12, 2016. Dedication of the Kentucky Soldiers Home Highway Marker, Harrods Creek, Ky. Attended by officers and past officers of the department, Congressman John Yarmuth (who gave a short talk), present owners of the original structure, and representatives from the Kentucky Historical Society, the Filson Historical Society, the American Legion and the NSDU 1861-1865. Followed by a reception in the original building. Local media covered the event.

March 19, 2017. Maintenance of the Granville Allen Monument, Morgantown, Ky. Six present and future members of Camp No. 1 visited the Granville Allen Monument order to clean the monument of weeds, moss and lichen which were encroaching upon the monument.

Ongoing: Finalizing the commemorative bench at the Sacramento, Ky, battlefield. Brother Keith Karcher updated the department on this project, which just came to the attention of the Department. The Department appropriated \$250 for engraving and placement.

#### **Future Projects**

Restoration of the Cave Hill NC Rostrum. The trellis roof of the Rostrum was removed in 1947. Members of Camp No. 1 and of the Department of Kentucky took upon themselves to promote the restoration of the trellis. The proposal was submitted to the Regional office of the Department of Veterans Affairs. Regional Director Michael Niklarz in turn submitted the proposal to the Washington office. The proposal was approved and funding for the project is in the works. The Memorial Officer requests that the Department fund the placing of a dedicatory plaque and the purchase and planting of foliage for the trellis once the project is completed.

Maysville G.A.R. monument. This monument in Mason County, dedicated on July 4, 1887, was erected by the local G.A.R. Joseph Heiser post in the Maysville Cemetery. The monument is not listed in an online compendium of Civil War monuments in Kentucky. The Memorials Officer proposes to apply to place the monument on the National Register of Historic Places.

#### **Charles Frederick Heider**

Private, 4th Regiment United States Cavalry
By Great-Grandson CC Robert Jones, Ft Duffield Camp No. 1
[Note: I would greatly appreciate sharing your ancestors' bios with me for this space]

My maternal great-grandfather Karl Frederick Heider was born in Benneckenstein, Prussia (modern Saxony-Anhalt), son of Christian and Barbara (Reckes) Heider, probably in 1837. Nothing is known of his early youth. According to immigration records, at the age of 18 he boarded the passenger ship *Tuisko* in Bremen, and arrived in New York on June 14, 1856, intending to make his way to Niagara. However, he ended up in Cincinnati, Ohio, a popular destination for many German emigrants. He listed his trade as baker.

On Sept. 10, 1861, Charles (the name he put on his enlistment papers) enlisted in the 4<sup>th</sup> U.S. Cavalry, and his papers were signed by 2<sup>nd</sup> Lt. Edward M. McCook of the famous "Fighting McCooks" family of Ohio. Shipped down river to Paducah, Kentucky for training, Pvt. Heider subsequently fought in the battles of Fort Donelson, Shiloh, Perryville, and Stones River. During the last named battle, Pvt. Heider was wounded in the leg and captured while on courier duty. He was paroled and released, but there was no record at the time of a wound. A fellow trooper testified later in an affidavit that Pvt. Heider returned to his regiment with neither horse nor boots.

Pvt. Heider continued to serve in the Tullahoma campaign under Gen. William Rosecrans and participated in the battle of Shelbyville on June 27, 1863. In July, he was transferred to the 4<sup>th</sup> U.S. Cavalry Regimental Band, and served in that capacity in the battle of Chickamauga and in Sherman's Atlanta campaign the following year. On Sept. 10, 1864, he was discharged at Sandtown, near Atlanta, Georgia, his three-year term of enlistment having ended, and suffering from malaria and skin disease.

Pvt. Heider made his way back to Cincinnati and Ohio, meeting 17-year-old Barbara Weiler soon after his return. They were married on Dec. 26, 1864 in Fremont, northern Ohio. They had six children, four of whom lived to adulthood. The youngest surviving son, Edward Harmon Heider, born in 1871, is my maternal grandfather. Charles Heider opened a bakery and grocery store in Fremont, but died in 1876 due to complications from an illness allegedly contracted while in the service. Barbara remarried in 1880, but her second husband died in 1887 while they were homesteading in South Dakota. She applied to the Pensions Bureau for a widow's pension in the late 1880s. However, due to the complications in the pension law regarding remarried widows, she did not begin receiving a pension until 1917.

Barbara Weiler Heider died in 1936, having outlived her Civil War veteran husband by 60 years. They are buried together in Fremont's Oakwood Cemetery. I had the honor of visiting and cleaning their graves in 2016. One final note is that the on the civilian-style gravestone, Pvt. Heider's regiment number is incorrect, listing it as the 1st Cavalry. The 1st Cavalry was renumbered the 4th Cavalry on Aug. 3, 1861.
